BYLAW NO. 952, 2000

A bylaw to amend Greater Vancouver Regional District
"Electoral Area C Advisory Planning Commission
Establishment Bylaw No. 835, 1996".

WHEREAS pursuant to section 898 (2) of the *Municipal Act* the Regional Board has adopted a bylaw to establish an Advisory Planning Commission for a portion of Electoral Area C;

AND WHEREAS Supplementary Letters Patent were issued, which effective December 10, 1999 redefined the boundaries of Electoral Area A to include the area formerly known as Electoral Area C and thus eliminated Electoral Area C;

AND WHEREAS given the change to electoral boundaries, the Regional Board has deemed it necessary to amend "Electoral Area C Advisory Planning Commission Establishment Bylaw No. 835, 1996";

NOW THEREFORE the Board of Directors of the Greater Vancouver Regional District in open meeting assembled, enacts as follows:

1. Greater Vancouver Regional District Electoral Area C Advisory Planning Commission Establishment Bylaw No. 835, 1996 is hereby amended.
2. All references to "Electoral Area C" in the bylaw shall be replaced with "Electoral Area A".
3. In section (2) of the bylaw, the words: "which do not include Bowen, Bowyer, Finisterre, Hutt, or Passage Islands and which are shown on the map attached hereto as Schedule 835-A" shall be replaced with the following words: "as illustrated on Schedule 952-A".
4. In section (3) of the bylaw, the words: "8 members" shall be replaced with the words "6 members".
5. In section (4) of the bylaw, the words: "Brunswick Beach" shall be replaced with the words "Pitt Lake".
6. Section 16 of the bylaw, which contains the following words: "The Commission may exclude persons other than its members from meetings", shall be deleted.

7. Section 17 of the bylaw, which contains the following words: "Notwithstanding section 16 above, where the Commission is considering an an amendment to a plan or bylaw, or the issue of a permit, the applicant for the amendment or permit is entitled to attend the meeting or meetings at which the matter is being considered, and to be heard", shall be deleted.



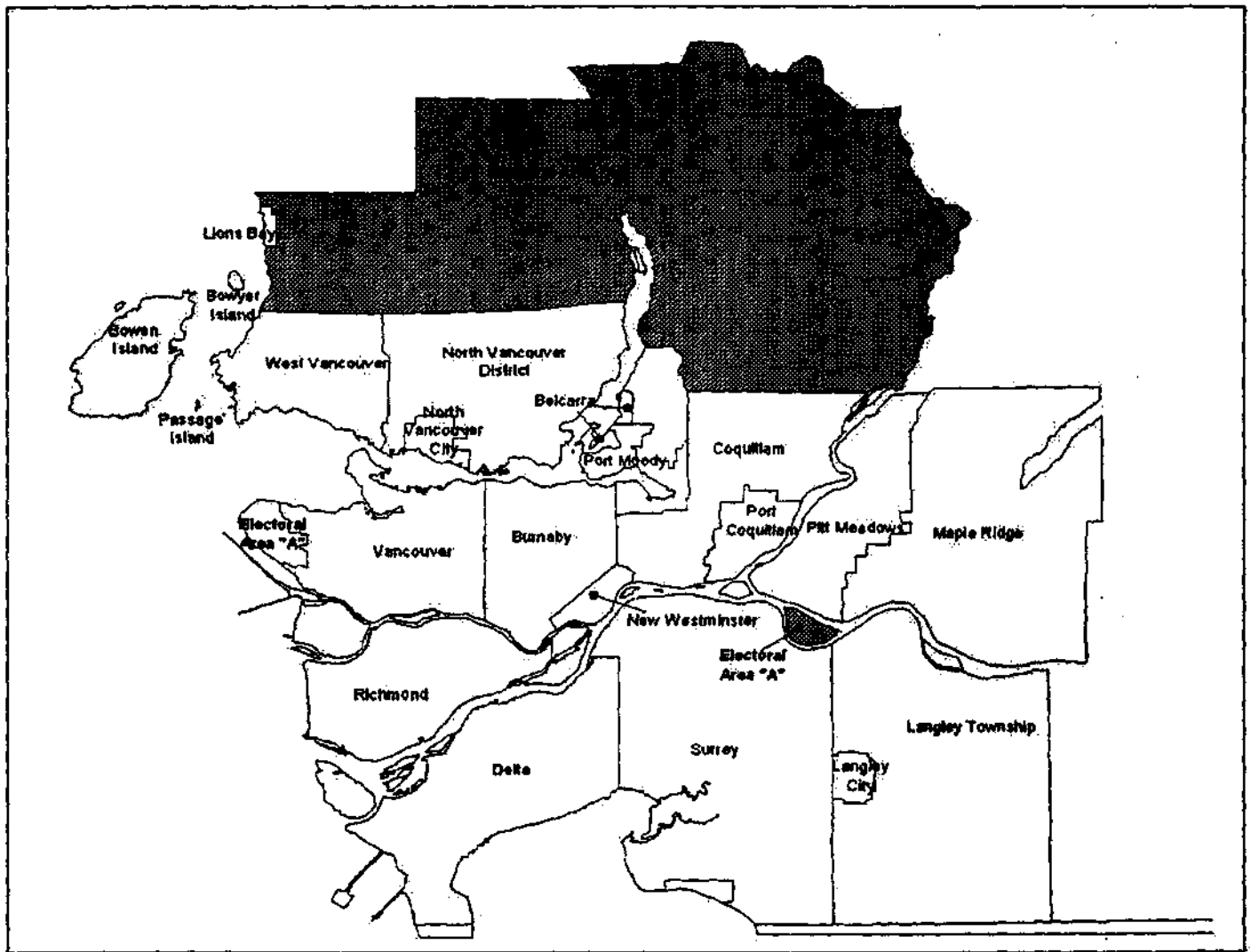
